- Responsible for vision, strategy, and goals for the overall organization
- · Obliged to establish policy and procedures
- · Review initiatives, campaigns and events to provide key decisions
- Ensure brand alignment within all initiatives
- · Act as a resource for the director and stakeholders alike
- · Monitor general society activities
- · Interact with the community as an ambassador
- Be well informed about the organization and its initiatives
- · Contribute skills, knowledge, and experience when appropriate
- · Listen respectfully to other view points even those you do not agree with
- Assume Leadership in board activities
- · Represent the nonprofit side to the residents, public, businesses and community organizations
- Will refrain from talking on behalf of the CBIA to media, officials but can discuss personal opinions and stances (board executive positions exempt President, Vice-President, etc.)
- Educate yourself about your areas needs, community needs, and socio economic circumstances within the area.
